Toyota Tsusho Co. (TTC) and Toshiba Plant System and Services Corp. (TPSC), as a Consortium, have successfully executed contracts to design, supply, install and put into successful operation the Balance of Plant equipment for two Combined Cycle Power Plant projects in Egypt, EL-ATF and SIDI KRIR, each 750MW (two CTGs, two HRSGs and one STG) through two contract packages executed at each of the two sites:

- CP-117 Contract Package titled "Electrical Equipment & Instruments Installations"
- CP-118 Contract Package titled "Mechanical Equipment & Piping Installations".

"EGYPTROL, Egypt Engineering Services, S.A.E." was awarded a number of sub-contracts through which TTC/TPSC Consortium conducted most of their scope related to testing, commissioning, start-up, instrument calibration, local procurement and operation of equipments and systems up to turning the plant over to the Owner. EGYPTROL executed its scope through its local staff, including coordination of related site activities and equipment vendors' activities.

EGYPTROL's awarded scope commenced with a lump sum contract for conducting Balance of Plant (BOP) equipments and systems commissioning activities, starting with preparation of commissioning procedures, effective 1<sup>st</sup> of April 2009. This first contract scope comprised responsibility for all commissioning activities to support TTC/TPSC in meeting the contractual milestone dates for operating EL-ATF power plant in Simple Cycle mode. EGYPTROL was then awarded a number of contracts for providing services in field instrument calibration, procurement support, plant operation, and commissioning support for both projects (EL-ATF and SIDI KRIR) in both phases (Simple Cycle phase and Combined Cycle). In fact, EGYPTROL services covered the complete Balance of Plant equipment and systems testing, commissioning, start-up and operation until turning over the plant to the Owner, for both plants. EGYPTROL was also awarded a contract for conducting all site activities related to the two years warranty scope for all four contract packages (CP-117 and CP-118 for both plants). These warranty scopes are expected to be concluded by 31<sup>st</sup> September 2012.

EGYPTROL provided experienced team members and supported them with remarkable leadership. EGYPTROL completed all scopes of work on-time and with the highest quality. The services EGYPTROL provided exceeded TTC/TPSC Consortium expectations and were instrumental in meeting the project objectives.
